Cash, Personal Cheque, Debit, Visa, Mastercard. We will accept four equal payments using post dated cheque or credit card (Visa & Mastercard) Payment plan can be arranged with management. All payment plans must be completed by July 1st 2025.

Rules and Conditions Payment Conditions

- Payment plan for membership will be automatically paid monthly by credit card or post dated cheques.
- Memberships must be paid in full by June 30th, 2025.
- Mountain Golf & Country Club/Glen Lovat Golf Club reserves the right to suspend memberships if not paid in full by June 30th, 2025.
- All House Accounts with Mountain Golf & Country Club/Glen Lovat Golf Club must have a valid credit card on file and agree to automatic monthly billing.
- House Accounts must be paid in full by October 31st, 2025. Mountain Golf & Country Club & Glen Lovat Golf Club reserves the right to charge account balance to credit card on file if not paid in full by October 31st, 2025.

General Regulations

- The opening and closing of the golfing season shall be at the discretion of management.
- Persons found damaging course property or equipment may have golf privileges suspended immediately.
- Personal property that is brought onto course property is solely at the risk of the person and the course shall not be responsible or liable to the member/ or guest for any loss thereof or damage thereto.
- Members and guests are responsible for any damages to power carts.
- Power cart use may be totally or partially restricted due to inclement weather at the discretion of management.
- No more than two power carts will be permitted per group. As cart packages are priced per seat, Mountain Golf & Country Club & Glen Lovat Golf Club reserves the right to rent the other seat on a single rider's power cart unless both seats are purchased.
- No member or guest shall bring outside alcohol on the premises. We as the Club reserve the right to restrict play in the event that alcohol is brought onto the property.
- Golf attire must be adhered to at all times.
- Members shall not be permitted to utilize the facilities when the course is closed, unless approved by management.

Turf Care Regulations

- Replace divots and repair ball marks on green. Rake sand traps.
- Be cautious with flagpoles on green and avoid causing turf damage with practice swings.
- Keep power carts at least 30 feet from the greens and travel on cart paths or in the rough whenever possible.
- Do not use bug spray on grass, especially on tees and greens as it causes turf damage.

Rules of Play

- All players must register in the pro shop prior to playing.
- The names of all players must be recorded when reserving tee-times. Incomplete foursomes may be filled.
- Pace of play must be adhered to at all times. Players failing to maintain the pace of play by falling behind more than one clear hole from those in front.
- Failure to cancel reserved tee-times or update amount of golfers may result in suspension of membership.
- Players must not start on the 10th tee without permission from the pro shop staff.
- There is no guarantee of tee time availability.
- Golfers will not be permitted to play before tee times start for the day. Maintenance staff have priority when mowing greens in the morning.
- All power carts must be returned to pro shop before dusk.

Membership Power Cart Package

- You have purchased one seat on the Power Cart. The Club reserves the right to assign another person who has the agreement to also ride on the power cart or another paid rider. If you wish to ride alone you will be required to pay for the other half of the power cart.
- We will not send out 2 power carts with 1 rider on each power cart. We would like to have maximum 2 power carts per group.
- Power Carts are not guaranteed just because you purchased the Membership Package with Cart.
- The membership with a cart will be good for Member club tournaments only any outside tournament you will be required to pay for your cart.

Membership Guidelines

- Proof of age may be requested at time of purchasing Membership
- Memberdship is not refundable or transferable
- The management of Mountain Golf & Country & Glen Lovat Golf Club reserves the right to revoke any Membership for conduct, action and behavior deemed to be detrimental to the operation of our Courses
- Individual Age 31+ 7 day play during available tee times.
- Individual (Monday Friday) 5 day play, Monday Friday during available tee times.
- Individual Out of County 7 day play during available tee times.
- Intermediate (19 -30) 7 day play during available tee times. Must not reach their 31st birthday before April 1st ,2025.
- Junior Member 7 day play during available tee times. Must not reach their 19th birthday before April 1st, 2025.
- Ladies Social League Ladies Night & Friday's.
- 9 Hole memberships allows you one 9 hole round per day. Extra fee will be charged for additional 9 Holes
- Out Of County Membership This does not apply to Colchester County & Pictou County Residents.
- Dual Membership 7 day play at either course. Dual Memberships will be sold as an add on to any Membership. If you purchase membership with cart package at your home course it will apply at the partner course. You are eligible to play in Club Championship at Mountain Golf & Country Club & Glen Lovat Golf Club.
